This club has a membership of all the interested students of the college. At the beginning of the academic year they form a team of office bearers to facilitate the smooth conduction of Moot Court activities.

- To train the student to prepare memorials for the competition by extensive research.

SPECIAL LECTURE SERIES

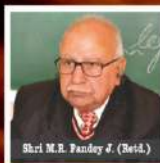

The Renaissance Law College provides Legal Aid Services with an objective to facilitate access to justice to the poor and marginalized and provide legal aid services to make right to legal aid as a reality. The Legal Aid committee consisting of students and faculty coordinator has been constituted to promote legal aid services by the students. It also aims to create an online forum to enable legal aid societies across law schools in India to come together, share experiences, bring about collaborative efforts and grow from the same.

PLACEMENT ASSISTANCE CRITERIA (PAC)

Renaissance Law College offers placement to the students subject to fulfilment of certain defined criteria such as overall class attendance, academic excellence, co-curricular activities. Curriculum has been designed in such a manner that the students are trained and groomed so that they become competent to take any job opportunity be it the law practise, a Government job or a corporate job.

A criterion that has been designed to ascertain the candidates who will be allowed to appear for the placement. All the students who aspire to take up a Corporate job will have to abide and fulfil the following criteria-

- Attendance - 80% and above.
- Academic Excellence - Over-all academic performance in all the internal exams as well as University Exam performance (i.e. a candidate securing First Division) will be evaluated as the basis for the judgment of this criteria.
- Co-curricular Activities - The student has to actively participate and come up with a good performance in all such co-curricular activities such as Moot Court, Trial, Assignment, Projects, Presentations and Viva etc.
- Extra-curricular Activities - The students have to actively participate in other ancillary activities such as sports, cultural/social activities organised by RLC (Law Fest, Indradhanush, Nidaan etc.)

A student not fulfilling the said criteria will be debarred from appearing in the placement which is to be offered in the end of the B.A.LL.B. Course.

College will try and provide ample opportunities to get the students placed and opt a better suitable career to the candidates complying the criteria.
