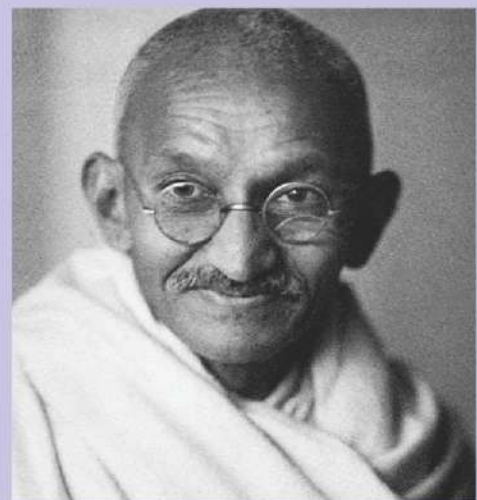

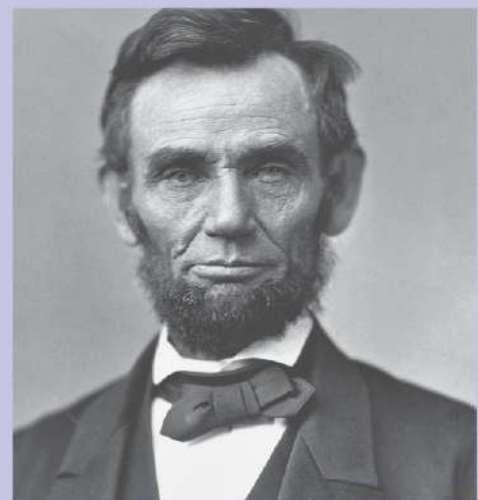

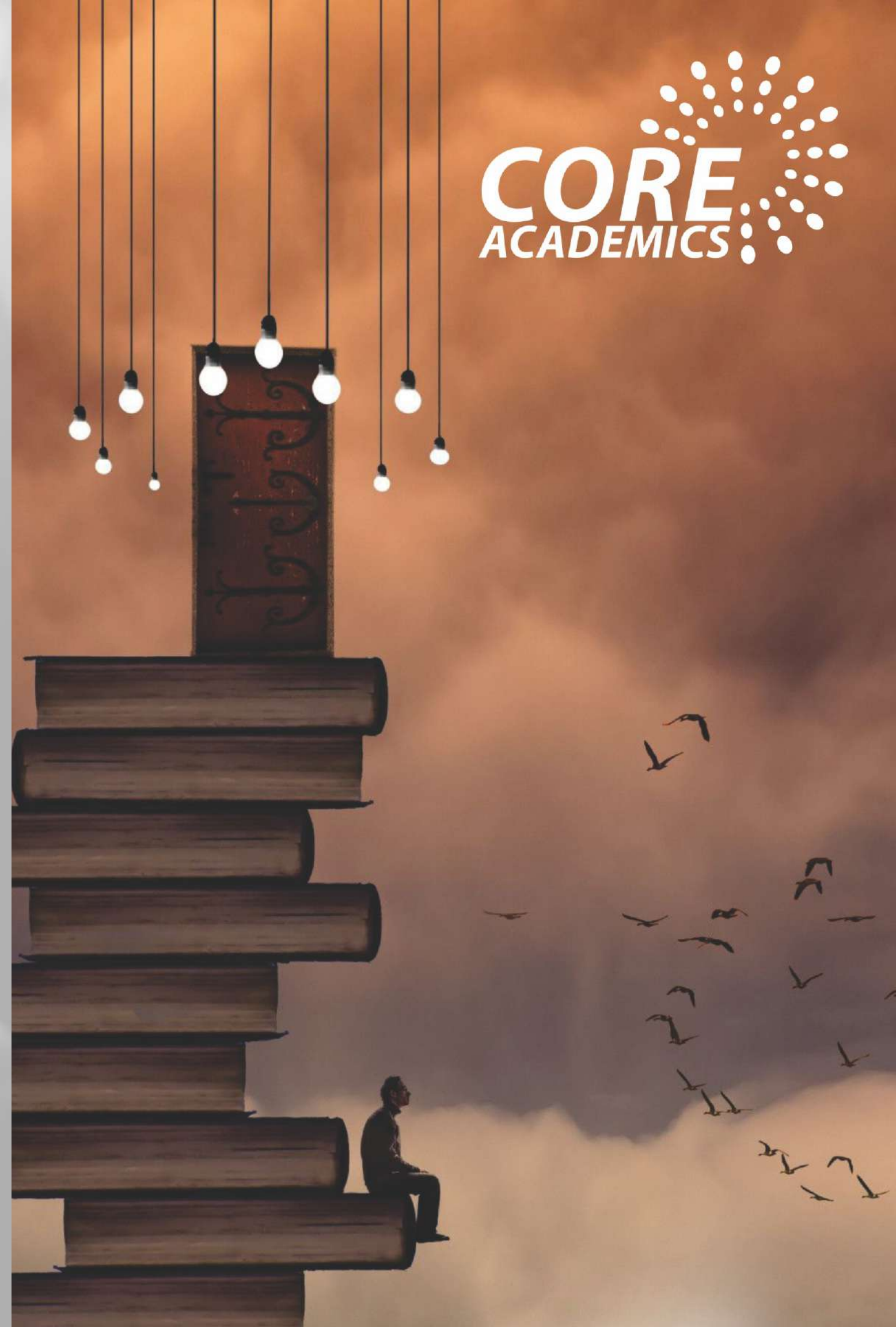

# CORE ACADEMICS





## SHODH (Research Week)

## ANATOMY OF CRIMINAL TRIAL

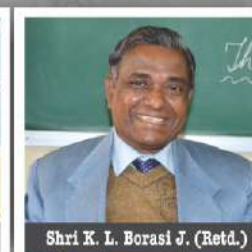
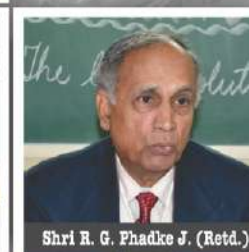
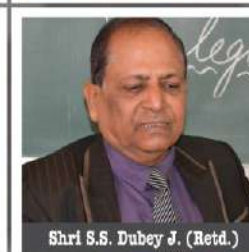
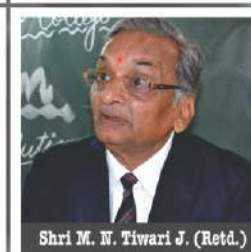
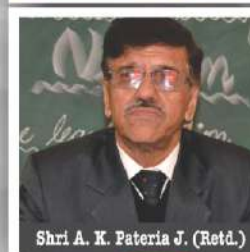
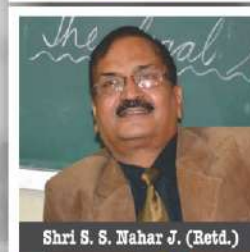
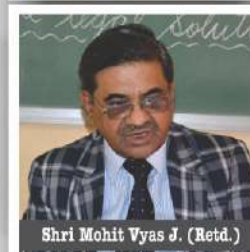
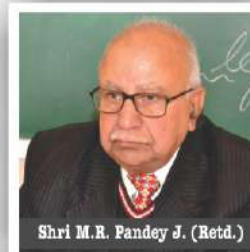
## NIDAAN

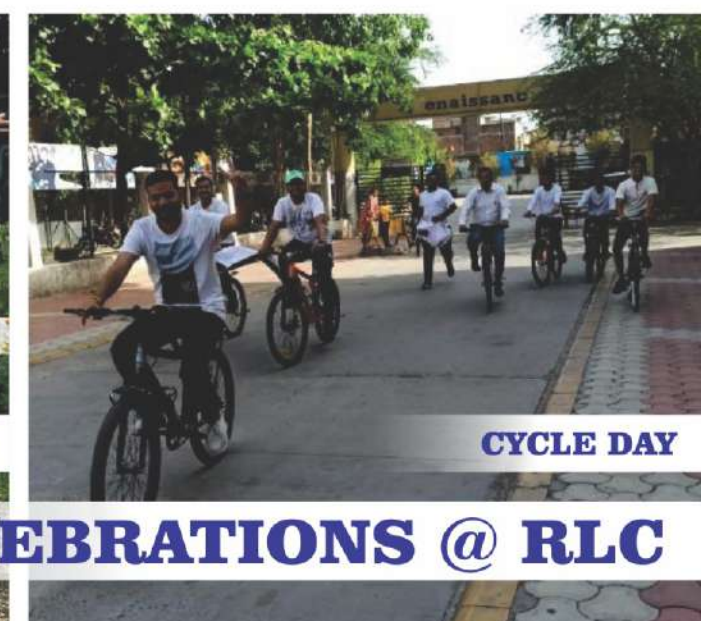
